



**AKG ACOUSTICS USA ANNOUNCES A TRADE-IN REBATE PROGRAM  
FOR 700 MHZ WIRELESS MICROPHONE SYSTEM COMPONENTS**  
**Offer Extended: March 1<sup>st</sup> 2010 through September 30<sup>th</sup> 2010**

The Federal Communications Commission (FCC) has re-appropriated the use of the 700 MHz band, used by many wireless microphones, wireless in-ear monitors, wireless production intercom systems and other professional wireless audio and video equipment, for use by public safety and commercial licensees. Under this new FCC rule, you will be prohibited from using some products operating in the 700 MHz band once the new restrictions take effect. Although this new rule does not apply to all uses of existing products and other exceptions to the new FCC rules apply, AKG Acoustics USA is providing an opportunity to trade-in your old 700 MHz system and get cash back on the purchase of a new AKG non-700 MHz band wireless system or components that comprise a system. Your 700 MHz band wireless microphone doesn't have to be prohibited, to qualify for the rebate.

Whether you're updating or replacing your 700 MHz wireless microphone system, AKG Acoustics USA is offering rebates of up to \$500 when you purchase either a new AKG wireless microphone system or a new AKG receiver and one or more new AKG transmitters from an AKG authorized dealer and you trade-in your existing 700MHz (698-806MHz) wireless system (receiver and transmitter(s)). Your trade-ins do not need to be AKG products, but they do need to be compatible components. Terms and conditions apply; read the rules for details.

This offer requires you to send AKG Acoustics USA one qualifying system trade-in, your proof of purchase of a rebate-qualifying purchase and the UPC label from your rebate-qualifying purchase. Your system trade-in can be an AKG system or a system made by another manufacturer, but your system trade-in must be designed and enabled to operate in the 700 MHz band, including the operational frequency range between 698 MHz and 806MHz. Rebate-qualifying purchases are purchases only of new WMS40Pro, WMS40Flexx, WMS40Dual, WMS450, WMS4500 and DMS700 products made between March 1, 2010 and September 30th, 2010 from authorized AKG Acoustics USA dealers located in the United States; eBay purchases are specifically excluded. You may not substitute any other product purchase for such rebate and purchases of used or repackaged products are also excluded. A qualifying system trade-in is one receiver and at least one transmitter, all products being compatible, in working condition and operable in the 700 MHz band range.
